## **Essential Functions**

• Embrace the mission, vision, and values of Open House Ministries

- Responsible for overall appearance, maintenance, and cleanliness of all buildings (interior and exterior), including parking lots and outdoor child care play area
- Supervise and guide all facilities staff members
- Responsible for implementation of cleaning and maintenance plans for OHM Annex and Family Resource Center
- Oversee and ensure that all facilities staff job duties are completed and in a timely manner
- Supervise overall campus appearance, neat and garbage free
- Supervise and lead the entirety of the Giving Back program
- Complete and submit all building inspection requirements and reports, i.e. boiler room inspections, backflow inspections/reports, elevator inspections, Fire Marshall inspections, etc.
- Procure all maintenance and cleaning supplies
- Oversee volunteer community project groups
- Perform all functions and duties of facilities staff as needed

- Demonstrated personal Christian faith and commitment to the Christian mission of the ministry
- Demonstrated leadership ability to lead and manage multiple employees
- Ability to make on-the spot appropriate decisions
- Ability to manage confidential duties in a professional manner
- Attendance and punctuality
